

TERMS OF SERVICE

Effective Date: December 15, 2019

Please read these Terms of Service ("Terms", "Terms of Service") carefully before using the <https://oig.io> website (the "Service") is owned and operated by Octagon Intelligence Group ("us", "we", or "our"). Your access to and use of the Service is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Service (the "Member"). By accessing or using the Service, you agree to be bound by these terms. If you disagree with any part of the terms then you may not access the Service.

[1] DESCRIPTION OF THE SERVICE. Octagon Intelligence operates the G195 Global Strategist Portal (the "Service") which provides each Member with various intelligence, training and community services. Unless stated otherwise, any new features that enhance or otherwise change the current Services shall be subject to this Agreement.

[2] CONTENT OWNERSHIP. Octagon Intelligence Group will retain copyright ownership and all rights related for the information authored and published through the Service, unless explicitly stated otherwise and in writing. For more information, please see our *Copyright Policy*.

[3] MEMBER RESPONSIBILITY. A Member acknowledges and agrees that Octagon Intelligence Group neither endorses the contents of any Member communications nor assumes responsibility for any threatening, libelous, obscene, harassing or offensive material contained therein, any

infringement of third party intellectual property rights arising therefrom, or any crime facilitated thereby.

[4] MEMBER COMMUNICATIONS. A Member understands that all information, data, links, text, software, music, sound, photographs, graphics, video, messages, or other materials (“Content”), whether publicly posted or privately transmitted, are the sole responsibility of the person from which such Content originated. Therefore, Octagon Intelligence Group does not guarantee the accuracy, integrity, or quality of such Content originating from Member Communications.

[5] MEMBER CONDUCT. [10] INDEMNITY. You agree to indemnify and hold Octagon Intelligence Group Ltd. and its subsidiaries, affiliates, officers, directors, agents, and employees, harmless from any claim or demand, including reasonable attorneys' fees, made by any third party due to or arising out of your use of the Services, your violation of this Agreement, or your violation of any rights of another. The Member further recognizes that the purpose and intent of this Service is for information purposes only, and therefore does not prescribe any particular action. Such application requires

consideration of various contexts and circumstances, and therefore Octagon Intelligence Group assumes no responsibility for any actions taken by any Member.

[11]. TERMINATION. If a revision is material we will try to provide at least 30 days notice prior to any new terms taking effect. By continuing to access or use the Service after those revisions become effective, you agree to be bound by the revised Terms.
